## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Alliance operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the LOTT Clean Water Alliance from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Alliance's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement of architectural and engineering services
- Cash receipting at main office
- Selected IT security policies, procedures, practices, and controls protecting financial systems, IT systems, and data
- Open public meeting minutes
- Financial condition and fiscal sustainability

## INFORMATION ABOUT THE ALLIANCE

Established in April 2000, the LOTT Clean Water Alliance became financially independent in July 2001. The Alliance has four government members, including the cities of Lacey, Olympia and Tumwater and Thurston County, and operates through the Interlocal Cooperation Act Agreement for Wastewater Management. Prior to July 2001, the Alliance was a component unit of the City of Olympia. Until 2006, the Alliance contracted with the City of Olympia for accounting and financial reporting services. The Alliance assumed responsibility for these services beginning January 2006.

The Alliance preserves and protects health, the environment and water resources by providing wastewater management services for the urban areas of northern Thurston County. Four elected officials, one appointed from each of the member governments, make up the Board of Directors that governs and provides policy direction for the Alliance. The Board appoints an Executive Director to oversee the Alliance's daily operations as well as its 77.75 employees. For the 2017-2018 biennium, the Alliance operated on a \$24.7 million operating budget and a \$40.6 million capital budget.
