AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Alliance operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the LOTT Clean Water Alliance from January 1, 2019 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Alliance's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable – credit cards
- Procurement – public works
- Compliance with public works projects – prevailing wages
- Electronic fund transfers – accounts payable and payroll
- Open public meetings – documentation of minutes, executive sessions and special meetings

INFORMATION ABOUT THE ALLIANCE

Established in April 2000, the LOTT Clean Water Alliance became financially independent in July 2001. The Alliance has four government partners, including the cities of Lacey, Olympia and Tumwater and Thurston County, and operates through the Interlocal Cooperation Act Agreement for Wastewater Management. Prior to July 2001, the Alliance was a component unit of the City of Olympia. Until 2006, the Alliance contracted with the City of Olympia for accounting and financial reporting services. The Alliance assumed responsibility for these services beginning January 2006. The Alliance preserves and protects health, the environment and water resources by providing wastewater management services for the urban areas of northern Thurston County.

Four elected officials, one appointed from each of the partner governments, make up the Board of Directors that governs and provides policy direction for the Alliance. The Board appoints an Executive Director to oversee the Alliance's daily operations as well as its 84.75 employees. For the 2019-2020 biennium, the Alliance operated on a \$26.9 million operating budget and a \$62.8 million capital budget.
